**Response:** If inhaled: Remove person to fresh air and keep comfortable for breathing.

Immediately call poison center or doctor and explain the type of exposure to the chemical(s) and provide the name of the chemical(s).

If swallowed: Rinse mouth. Do NOT induce vomiting.

If on skin (or hair): Take off immediately all contaminated clothing Rinse skin with water/shower .

Wash contaminated clothing before reuse.

Specific treatment - refer to poison center or doctor for advice.

If in eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

### 4 FIRST AID

**After Inhalation:**

If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention immediately.

**After Skin Contact:**

Immediately remove contaminated clothing under a safety shower. Flush all affected areas with large amounts of water for 15 minutes. DO NOT attempt to neutralize with chemical agents. Obtain medical advice.

**After Eye Contact:**

Immediately flush the eyes with large quantities of running water for 15 minutes. Hold the eyelids apart during the flushing to ensure rinsing of the entire surface of the eyelids with water. DO NOT attempt to neutralize with chemical agents. Obtain medical attention as soon as possible. Oils or ointments should not be used. Continue rinsing for an additional 15 minutes if the physician is not available.

**After Ingestion:**

If swallowed: Rinse mouth. Do NOT induce vomiting.

- Reactivity:** Reacts violently with water, organic substances and base solutions with evolution of heat and hazardous mists.
- Chemical Stability:** Stable under normal conditions

<b>Incompatible Materials:</b>	Vigorous reactions with: water;alkaline solutions;metals, metal powder, Carbides;Chlorates;Fulminates;nitrates,picrates, strong oxidizing, reducing, or combustible organic materials. Hazardous gases are evolved in contact with chemicals such as cyanides, sulfides, and carbides. Sulfuric acid reacts with metal to produce hydrogen, a flammable and potentially explosive gas. Hydrogen reacts with sulfides and generates hydrogen sulfide(Highly toxic gas). NEVER add water directly to sulfuric acid because a violent exothermic reaction may occur.
