If swallowed: Rinse mouth. Do NOT induce vomiting.

If in eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.
If on skin (or hair): Take off immediately all contaminated clothing. Rinse skin with water/shower.
If exposed or concerned: Get medical advice/attention.

Storage: Store locked up.

4 FIRST AID

After Inhalation:

Move to fresh air. If breathing is difficult, give oxygen. If breathing stops, provide artificial respiration. Do not use mouth-to-mouth method if victim inhaled the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one way valve or other proper respiratory device. Call a physician or poison control center immediately.

After Skin Contact:

Take off immediately all contaminated clothing. Wash off IMMEDIATELY with plenty of water for at least 15-20 minutes. Get medical attention immediately! Wash clothing separately before reuse. Destroy or thoroughly clean all contaminated shoes.

After Eye Contact:

Immediately flush with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do so. Continue rinsing. Call a physician or poison control center immediately.

After Ingestion:

Call a physician or poison control center immediately. Do not induce vomiting. Immediately rinse mouth and drink plenty of water. If vomiting occurs, keep head low so that the stomach content doesn't get into the lungs. Never give anything by mouth to an unconscious person. Do not use mouth-to-mouth method if victim ingested the substance.

Most Important Symptoms/Effects

Delayed:

Burning pain and severe corrosive skin damage. Permanent eye damage including blindness could result. Symptoms may include stinging, tearing, redness, swelling, and blurred vision. Shortness of breath.

Indication of immediate medical attention:

Provide general supportive measures and treat symptomatically. Symptoms may be delayed. Keep victim under observation.

Special Precautions / Procedures:

Emergency personnel should protect against secondary contamination.

5 FIRE FIGHTING MEASURES

Suitable and Unsuitable extinguishing media:	Water fog. Foam. Dry Chemical powder. Carbon Dioxide (CO ₂). Use extinguishing agent suitable for type of surrounding fire. Do not use solid water stream as it may scatter and spread fire. Do not use halogenated extinguishing agents.
Specific hazards arising from the chemical:	The product itself does not burn. May decompose upon heating to produce corrosive and/or toxic fumes. Contact with metal may release flammable hydrogen gas.
Special protective equipment and precautions for firefighter	Fire fighters should enter area only if they are protected from all contact with the material. Full protective clothing, including self-contained breathing apparatus, coat, pants, gloves, boots and bands around legs, arms, and waist, should be worn. No skin surfaces should be exposed.

6 ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, & Emergency Proc	Prevent spilled product from drains, sewers, waterways and soil. Wear appropriate chemical protection equipment such as gloves, face-shield, goggles and suitable body protection to prevent contamination of skin, eyes and personal clothing.
Methods and Materials for containment & cleaning up:	If trained in accordance 29 CFR 1910.120, leaks should be stopped. Spills should be contained and cleaned immediately. 7 HANDLING AND STORAGE

Precautions for safe handling:	Use caution when combining with water. DO NOT add water to Caustic. ALWAYS add caustic to water while stirring to minimize heat generation. Do not get in eyes, skin or on clothing. Do not taste or swallow. Do not breath vapor or mist. Use only with adequate ventilation. Wear appropriate personal protective equipment. Transfer and storage systems should be compatible and corrosion resistant. Observe good industrial hygiene practices.
Conditions for safe storage, inc any incompatibilities:	Keep container tightly closed. Store in cool dry place. Store away from incompatible materials. (See section 10). Do not allow material to freeze. Store in corrosive resistant container.
